

**ORDINANCE 2017-19**

**AN ORDINANCE OF THE ELLETTSVILLE TOWN COUNCIL  
VACATING A PUBLIC WAY**

**BE IT ORDAINED AND ADOPTED** by the Town Council of Ellettsville, Indiana,

**WHEREAS**, the Monroe County Public Library has requested that the alley and public way between its property located between lots 41 and 42 (parcel numbers 53-04-10-200-186.000-013 and 53-04-10-200-154.000-013, respectively) in Sharp's first addition be vacated; and

**WHEREAS**, lots 41 and 42 are the only properties being injuriously or beneficially affected; and

**WHEREAS**, the Town of Ellettsville has statutory power pursuant to Indiana Code § 36-7-3-12(e) to vacate such alley and public way; and

**WHEREAS**, the Town Council of the Town of Ellettsville desires to vacate said alley and public way; and

**WHEREAS**, due notice has been given by publication at least one time at least ten days before the hearing.

**NOW, THEREFORE, BE IT HEREBY ORDAINED AND ADOPTED BY THE TOWN COUNCIL OF ELLETTSVILLE, MONROE COUNTY, INDIANA**, that:

**SECTION 1.** Due notice by publication has been published one time at least ten days before the hearing.

**SECTION 2.** The Ellettsville Town Council met to receive and hear remonstrances from any persons interested in, or affected by, the vacation of said alley between lots 41 and 42 in Sharp's first addition to the Town of Ellettsville on the 27<sup>th</sup> day of November 2017 at 6:30 p.m. and on the 11<sup>th</sup> day of December 2017 at 6:30 p.m. The Town Council held hearings on both dates to consider evidence and arguments against and in favor of the Monroe County Public Library's petition. After considering the evidence and the arguments, the Town Council determined that the alley between lots 41 and 42 in Sharp's first addition to the Town of Ellettsville should be, and hereby are, ordered vacated.

**SECTION 3.** The alley between lots 41 and 42 in Sharp's first addition to the Town of Ellettsville, Monroe County, Indiana is hereby vacated and ordered transferred by the Auditor of Monroe County, Indiana to the Monroe County Public Library.

**SECTION 4.** That the Town Clerk-Treasurer shall furnish a copy of this vacation ordinance to the Recorder of Monroe County, Indiana for recording, and to the Auditor of Monroe County, Indiana.

This Ordinance Vacating a Public Way was adopted by the Ellettsville Town Council on the 27<sup>th</sup> day of December, 2017 at the Ellettsville Town Hall, Ellettsville, Indiana.



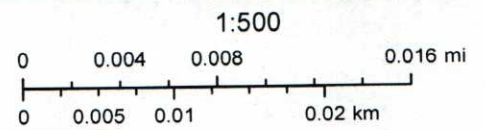
