Request is to rezone 60 acres of a 74-acre parcel to Light Industrial. 14 acres will remain agricultural. They have given a favorable recommendation of 6-0 to Town Council. Kevin provided a map explaining the area is located just west of the Lifeway Baptist church and before the Boys & Girls Club.
