The Ellettsville, Indiana Town Council met for a special meeting on Monday, October 27, 2025, at the Ellettsville Town Hall Meeting Room located at 1150 West Guy McCown Drive. Scott Oldham called the meeting to order at 6:30 p.m. Chief Jimmie Durnil gave a word of prayer followed by the Pledge of Allegiance by Kevin Patton, Fire Chief.

#### **Approval of the Minutes for the Regular meeting October 17, 2025**

**Scott Oldham** entertained a motion for approval of the minutes of the regular meeting on October 17, 2025. William Ellis so moved. Trevor Sager seconded. All in favor, motion carries.

#### **Resolutions**

##### **Resolution 34-2025 to Adopt Monroe County Multi-Hazard Mitigation Plan**

**Kevin Patton**, Fire Chief explained this plan is through the EMA Director's Office through Federal Emergency Management Agency (FEMA). It's a roadmap updated every 5 years that tells the local government how to proceed with disasters to get reimbursed should FEMA need to come in. William Ellis made a motion to approve Monroe County Multi-Hazard Mitigation Plan. Trevor Sager seconded. The Fire Department participated to review it and they have a positive recommendation for it. Roll call vote: Scott Oldham – yes; William Ellis – yes; Trevor Sager– yes. Motion passes.

#### **Ordinance on First Reading**

##### **Ordinance 2025-25 Creating a Separate Vehicle Replacement Fund for the Stormwater Utility**

**Kip Headdy**, Street Commissioner discussed having a vehicle replacement line for Stormwater Utility. He has equipment that is creeping up in age and he wants to put money in a budget for future equipment purchasing. It would be a non-reverting fund. It is funded by a portion of Stormwater fees.

##### **2026 Monroe County Interlocal Agreement with Animal Control**

**Darla Brown**, Town Attorney explained this is the proposed annual agreement between the City, County and the Town of Ellettsville for the animal shelter and management interlocal agreement. The packet contained information on animals surrendered, projected costs and animals picked up from various sources. In 2025 we were to pay \$22,150 and we have a budget amount of \$28,350 but we do have additional funds to make this one. The Town agrees to pay the City the sum of \$37,492 in reimbursement for Shelter operations expenditures. William Ellis made a motion to approve 2026 Monroe County Interlocal Agreement with Animal Control. Trevor Sager seconded. Roll call vote: Scott Oldham – yes; William Ellis – yes; Trevor Sager– yes. Motion passes.

#### **Appointment to Monroe County Animal Management Commission**

**William Ellis** explained they just need the Town Attorney to give them a form to say he was appointed because they are not recognizing it. Darla Brown, Town Attorney stated they should vote again. Trevor Sager made a motion to appoint William Ellis as the Monroe County Animal Management Commission member from Ellettsville Town Council. Roll call vote: Scott Oldham – yes; William Ellis – yes; Trevor Sager – yes. Motion passes.


