## **ORDINANCE 2022-03**

## TO AMEND THE ELLETTSVILLE TOWN CODE TO INCREASE RATES AND CHARGES FOR WATER SERVICE PURSUANT TO THE INDIANA UTILITY REGULATORY COMMISSION'S APPROVAL OF THE TOWN'S REQUEST TO INCREASE THE WHOLESALE COST TRACKING FACTOR IN 30-DAY FILING NO. 50484

BE IT ORDAINED AND ADOPTED by the Town Council of Ellettsville, Indiana:

<u>Section 1</u>. The following revisions are hereby made to Section 51.32 of the Ellettsville Town Code in order to increase the tap and meter installation charges as approved by the IURC on April 6, 2022:

## § 51.32 TAP AND METER INSTALLATION CHARGES.

(B)(1) The charges for installing new service shall be:

Five-eighths inch by three-fourths inch service with excavation	\$1,510.00
Five-eighths inch by three-fourths inch service, with bore	\$1,960.00
Five-eighths inch by three-fourths inch service, no excavation	\$1,180.00
Five-eighths inch by three-fourths inch service, pre-installed with excavation	\$1,320.00
Five-eighths inch by three-fourths inch service, pre-installed, no excavation	\$ 990.00
Five-eighths inch by three-fourths inch service, water only meter	\$ 430.00

Section 2. The following revisions are hereby made to Section 51.32(B)(2) of the Ellettsville Town Code, as approved by the IURC on April 6, 2022. When an existing section of the ordinance is being amended, the text of the existing provision will appear in this style type, additions will appear in this style type, and deletions will appear in this style type.

51.32(B)(2) The charge for a service larger than a **the** five-eighths 5/8 by three-fourths inch service **meter tap** shall be the cost of labor, materials, power machinery, transportation, and overhead incurred for installing the tap, but shall not be less than the charge for a five-eighths by three-fourths inch service 5/8 inch meter tap.

<u>Section 3</u>. The following revisions are hereby made to the subsection (A) in the Appendix of Section 51.31 of the Ellettsville Town Code to increase the Monthly Water Usage Charges, as approved by the IURC on April 6, 2022.
