

**ORDINANCE 2022-08**

**SCHEDULE OF WATER RATE AND CHARGES  
TO DECREASE RATES FROM IMPLEMENTATION OF HEA 1002  
REPEALING THE UTILITY RECEIPTS TAX  
(Pursuant to 30-Day Filing No. 50525 Before the  
Indiana Utility Regulatory Commission and Approved June 28, 2022)**

**BE IT ORDAINED AND ADOPTED** by the Town Council of Ellettsville, Indiana:

**Section 1.** The following revisions are hereby made to subsection (A) in the Appendix of Chapter 51 (“Water”) of the Ellettsville Town Code to decrease the Monthly Water Usage Charges as approved by the IURC on June 28, 2022:

(A) *Metered usage; monthly charges.* There shall be and are established for the use of the service rendered by the waterworks system of the town the following rates and charges, which are based upon the use of water supplied by the waterworks system.

For use of and Service rendered by the waterworks system of the Town, based upon the use of water supplied by said waterworks system:

First 3,000 gallons	5.39
Next 5,000 gallons	4.87
Next 12,000 gallons	4.23
Next 30,000 gallons	4.00
Next 50,000 gallons	3.81
Next 100,000 gallons	3.68
Over 200,000 gallons	3.58

The rate shown includes a water tracking factor of \$0.85 per 1,000 gallons.

**Section 2.** The following revisions are hereby made to subsection (B) in the Appendix of Chapter 51 of the Ellettsville Town code to decrease the Monthly Water Usage Charges as approved by the IURC on June 28, 2022:

(B) *Metered User; minimum monthly charges.* Each user shall pay a minimum charge in accordance with the following applicable size of meter installed, for which the user will be entitled to the quantity of water set out in the above schedule of rates.

**Section 3.** The following revisions are hereby made to subsection (C) in Appendix A in Chapter 51 of the Ellettsville Town Code 51.32(B)(2) of the Ellettsville Town Code, as approved by the IURC on June 28, 2022.

(C) *Fire hydrant charges.* In addition to the basic monthly water rate, there shall be an additional monthly charge for fire protection according to the following schedule.

(1) Municipal hydrants.

Section 4. The following revisions are hereby made to subsection (D) in Appendix A in Chapter 51 of the Ellettsville Town Code approved by the IURC on June 28, 2022.

- (D) Automatic sprinkler systems. Water furnished for use by automatic sprinkler systems shall be charged for monthly on the basis of the size of connection needed to adequately supply the sprinkler systems as follows.
